## **COOPERATION AGREEMENT**

I.

The cooperation agreement establishes partnership relations between the Faculty and the Professional Practice Provider. Taking into account the importance of supplementing theoretical knowledge with practical, the Faculty of Civil Engineering and Professional Practice Provider hereby confirm the need and willingness to work together for the purpose of increasing the quality of educational and professional work that is realized in the form of professional practice. The signatory parties to this Agreement express their intention and desire to pursue and promote cooperation in areas of mutual interest, interest of the wider community and public awareness of education in the field of civil engineering, architecture and urban planning in Bosnia and Herzegovina.

П

The purpose of this cooperation is to create a basis for future cooperation of the signatories in the areas of mutual interest, which includes: organizing student practice for students of undergraduate and graduate studies of civil engineering and architecture and urban planning according to identified need of the Faculty, cooperation in complementing theoretical knowledge through practical involvement of students in working environment, development of teaching activities, guest lectures of representatives of the Professional Practice Provider, promotion of lifelong education and increasing the quality of the education system as a whole. The Professional Practice Provider is not obligated to pay the student a compensation for doing work on the professional practice and will not have any expenses on the basis of this cooperation.

III.

The cooperation established by this Agreement should be based on the principles of mutual trust, good faith and best practice and will be based on free exchange of knowledge and information in the areas covered by this Agreement.

IV.

For the needs of the Professional Practice Provider, the Faculty can also organize and in cooperation carry out lifelong education programmes as well as education in the areas of

application of modern knowledge and processes in the field of civil engineering, architecture and urban planning.

V.

With this agreement, the signatories express their willingness to cooperate in the organization of conferences, round tables, lectures and all other forms of cooperation for the promotion and development of the profession of civil engineering, architecture and urban planning.

VI.

The Parties to the Agreement shall mutually exchange scientific and professional publications and other publications of interest for the signatories in order to jointly promote public awareness of the importance of engaging the profession in the fields of construction, architecture and urban planning.

## VII.

Both parties agree that they will not disclose confidential information on partner institutions that they obtain under this Agreement.

The Faculty and Professional Practice Provider accept that the media inform the public about joint activities with the prior consent of both parties.

## VIII.

This agreement may be amended only with the written consent of both parties. Both Signatory Parties agree that any form of dispute between them arising from this Agreement shall be resolved amicably, promptly and in good faith.

## IX.

The Agreement is concluded for an indefinite period. Each party may cancel the Agreement in writing with a termination period of three months from the date of submitting a written notice.

X.

This Cooperation Agreement is made in four copies, of which each party keeps two copies.
